### **General Information**

#### Introduction

The Options Market Maker Rank report will be made available daily MTD for ARCA Options and MTD & QTD for AMEX Options and allows each Market Making Firm to evaluate their performance against their peers by Symbol. The report will include all symbols traded on the NYSE ARCA or NYSE AMEX Options Trading Platforms respectively, even if the subscribing Firm is not a registered Market Maker for a symbol and even if the Symbols MM Volume is zero. In addition, this report provides the Average National Daily Customer Contract Volumes and the symbols associated Rights Fee Tier that Market Makers can use to estimate Rights Fee charges per symbol.

The report will be made available by CRD# and will include data back to the 1<sup>st</sup> of the month/quarter of the reporting period. Requests for any previous reporting periods prior to activation will not be supported.

#### Naming Conventions and Formatting

- 1) Output files will be made available for secure pick-up via Managed File Transfer (MFT).
- 2) Output file will conform to the following standards:
  - 1. All files will be comma delimited.
  - 2. Headers will not be provided.
  - 3. Files will be compressed and delivered as .dat.gz
  - 4. File naming convention will support standard versioning controls.
- 3) Output files will be provided by CRD# only and follow standard naming convention:

- 4) As new enhancements are made to these outputs, customers may expect to receive both current and new versions in their MFT file folder. All new versions will be tagged with a version number which will then allow the customer to migrate to the new file format when ready. Advance notification of dates will be provided with a minimum of 30 day notice dependent upon size and scope of changes.
  - 5. After the migration timeframe has expired, customers will see only the latest version in their MFT folders.
- 5) Output Files will be available by ~ 6 a.m on T+1.

1) Report Output will be sorted daily by National Symbol Ranking.
